1 **JUDGMENT**

2 In accordance with, and for the reasons stated in the Order Granting Final Approval of
3 Class Action Settlement, judgment shall be entered whereby Plaintiff Estuardo Ardon and all
4 Settlement Class Members shall take nothing from Defendant City of Los Angeles except as
5 expressly set forth in the Second Amended Settlement Agreement, the Order approving the
6 parties' Stipulation Amending Second Amended Settlement Agreement in Certain Respects,
7 Amending Claim Form and Extending Claims Filing Deadline (together, the "Settlement
8 Agreement"),¹ and the Order Granting Final Approval of Class Action Settlement. Each side shall
9 bear their own costs and fees except as otherwise ordered in the Order Granting Final Approval of
10 Class Action Settlement and in the Settlement Agreement.

11 This Judgment does not apply to those Settlement Class Members who have timely
12 requested exclusion from the Settlement Class and are therefore not bound by this Judgment. A
13 list of excluded Settlement Class Members is attached hereto as Exhibit A.

14 Pursuant to California Code of Civil Procedure sections 578 and 664.6 and California
15 Rules of Court, rule 3.769(h), the Court, in the interests of justice, there being no just reason for
16 delay, expressly directs the Clerk of the Court to enter this Judgment, and hereby decrees, that
17 upon entry, it be deemed as a final judgment with respect to all claims by members of the
18 Settlement Class against the City and the Released Parties, in accordance with the terms of the
19 Settlement Agreement.

20 Without affecting the finality of this Judgment, this Court reserves exclusive and
21 continuing jurisdiction over the Settlement and the Settlement Agreement, including the
22 administration and consummation of the Settlement Agreement.
