STIPULATION CONTINUING CLAIMS FILING DEADLINE, FINAL FAIRNESS HEARING AND RELATED  
DATES; [PROPOSED] ORDER THEREON

1 Plaintiff Estuardo Ardon (“Plaintiff”) and Defendant City of Los Angeles (“City”), by and  
2 through their respective counsel of record, hereby respectfully submit this stipulation and  
3 proposed order:

4 WHEREAS, the deadline for class counsel to file motions for final approval and for an  
5 award attorneys’ fees and costs is currently January 15, 2016 (at least 40 days prior to the final  
6 fairness hearing);

7 WHEREAS, the deadline for objections is currently January 26, 2016;

8 WHEREAS, the deadline for exclusion requests is currently February 11, 2016;

9 WHEREAS, the deadline for class members to submit a claim form is currently February  
10 20, 2015;

11 WHEREAS, the final fairness hearing concerning the settlement preliminarily approved by  
12 the Court on September 8, 2015 is currently scheduled for February 25, 2016 at 11:00 a.m.;

13 WHEREAS, the parties have learned that some Class members have had difficulty  
14 obtaining historic phone records and, therefore, Plaintiff has served subpoenas on telephone  
15 carriers seeking information concerning their ability to provide telephone utility tax (“UUT”)  
16 payment data and the costs of retrieving it;

17 WHEREAS, the parties have had, and continue to have, discussions with several major  
18 phone carriers concerning their ability to provide, and the cost of providing, class members’ UUT  
19 payment records;

20 WHEREAS, the parties agree that the deadline to file claims should be extended by 90  
21 days to allow Class members more time to locate records and to facilitate the parties’ efforts to  
22 resolve the record retrieval issues with the carriers;

23 WHEREAS, the parties agree that the other deadlines set forth above should also be  
24 extended in light of the extension of the claims period;

25 WHEREAS, the parties agree to place notice of the extended deadlines on the settlement  
26 website as soon as possible and also contemplate that they may be able provide additional  
27 information on the settlement website concerning how class members can obtain their UUT  
28 payment records and notify class members who have already submitted claims of the opportunity

1 to file an amended claim;

2 WHEREAS, the parties contemplate that reminder postcards will be mailed to Class  
3 members within 60 days, which will remind Class members to submit claims, advise them of the  
4 extension of deadlines, advise them of any additional information from the carries that may be  
5 available concerning retrieval of their records of UUT payment, and referring them to the  
6 settlement website for additional information concerning;

7 **THEREFORE, IT IS HEREBY STIPULATED** by and between the parties hereto, by  
8 and through their respective counsel of record, that, subject to Court approval:

9 (1) The deadline for class members to submit a claim is extended to May 20, 2016;

10 (2) The deadline for class counsel to file a motion for final approval and for an award of  
11 attorneys' fees and costs is extended to July 1, 2016;

12 (3) The deadline for objections is extended until July 12, 2016.

13 (4) The deadline for exclusion requests is extended to July 28, 2016;

14 (5) The Final Fairness Hearing is continued to August 11, 2016 at 10:00 a.m.;




